

UNITED SUPREME COUNCIL PROPOSED AMENDMENT TO THE CONSTITUTION AND BYLAWS VOTING SESSION NOTIFCATION



Saturday, August 3, 2024, during the United Supreme Council Meeting

Persons Eligible to Vote: All Elected Officers of The United Supreme Council Staff, All Inspector Generals, Current Illustrious Commanders in Chief, in a Consistory in good financial standing with this United Supreme Council.

To: The Illustrious Lieutenant Sovereign Grand Commander, Illustrious Grand Prior, Illustrious Grand Chancellor, Illustrious Grand Minister of State, all Illustrious Elected Officers Past and Present, Illustrious Honorary Past Most Puissant Sovereign Grand Commander, All Inspectors General, Commanders in Chief, All Consistory Officers and Sublime Princes of the Royal Secret

Over the past few months, the currently elected Supreme Department Heads BOTH male and female have discussed and decided to introduce the following legislation for your collective approval, that "The First Four Elected Principal Supreme Officers of one Supreme Affiliated Department shall not be eligible to accept nomination for, be elected to, temporarily hold or be appointed to any of the First Four Elected Positions in any other Supreme Affiliated Department".

Our rationale for the aforementioned is as follows:

- 1. It allows for a greater diversity in the leadership structure of the Supreme Affiliation that directly reflects the diversity of the different states that comprise our Supreme Affiliation.
- 2. It allows the elected officer the opportunity to be fully focused upon the task that they have been elected to, thereby allowing them to be of greater benefit to their Supreme Department in specific and the Supreme Affiliation in general.
- 3. It allows for an increase in opportunities for our fellow members to seek leadership positions within our Supreme Affiliation, thereby increasing our current rate of participation.
- 4. It will also increase our ability to entertain and receive new ideas and innovations that may help to improve our efficiency and productivity throughout the entire Supreme Affiliation.

After discussion, debate and a favorable two-thirds vote of this proposition, this new rule will take effect the 102nd Biennial Supreme Council Session in the year of 2026.

Furthermore, the aforementioned verbiage shall be placed within the Constitutions and Bylaws of said Supreme Department to memorialize the same.

Finally, a copy of this voted on and approved legislation will be signed by each current Elected Officer of said Supreme Department, as ratification for its individual Supreme Affiliated Department and its combined membership in perpetuity.
